Standard Operating Procedures (SOP) for Empanelment of Primary Cooperative Societies (PACS)/ Farmer Producer Organisation/Company (FPO/FPC) for Procurement under Price Support Scheme (PSS) PM-AASHA

1. Background

- 1.1. Government of Uttar Pradesh, Department of Agriculture (Section-2) vide GO No 826/2026-2063438/12-2099/55/2023 dated 25-06-2026, has designated HOFED as a State Level Agency for the Procurement of Black Gram (Urad), Green Gram (Moong) & Groundnut (Mungphali) during Summer-2026 under the Price Support Scheme.
- 1.2. Govt of India, Ministry of Agriculture & Farmers Welfare, Department of Agriculture & Farmers Welfare, vide Letter No-L-15016/95/2020-MPS (E-91262) dated 11-11-2025 has issued revised instructions regarding implementation of Price Support Scheme under PM-AASHA. As per Para-2(A)(x) of the said letter, State Agencies may involve Primary Cooperative Societies (PACS), Farmer Producer Organisations (FPOs) and Farmer Producer Companies (FPCs) in procurement operations subject to prescribed conditions.
- 1.3. In compliance with the above, Instructions issued by State Government and applicable scheme Guidelines, The HOFED invites proposals from eligible PACS/FPO/FPC for empanelment to procurement of notified produce.
- 1.4. The Tentative List of proposed districts is attached.
- 1.5. This EoI is only for empanelment, It does not give guarantee for allocation of procurement targets or create any contractual obligation.

2. Objective

- 2.1. To facilitate procurement of notified pulses & Oilseeds under the PSS from eligible farmers.
- 2.2. To strengthen decentralized procurement through participation of eligible PACS/FPO/FPC.
- 2.3. To ensure transparency, accountability and compliance with GoI/Govt of UP Guidelines.

3. Commodities

- 3.1. Procurement may be undertaken for the following pulses & oil seeds (subject to target allocation):
 - a) Black Gram (Urad)
 - b) Green Gram (Moong)
 - c) Groundnut (Mungphali)

4. Scope of Work

- 4.1. Responsibility of Empanelled PACS/FPO/FPC is as under :
 - a) Registration of farmers through biometric authentication.
 - b) Ensure procurement strictly from eligible farmers.
 - c) Ensure compliance with FAQ (Fair Average Quality) norms.
 - d) Arrange necessary infrastructure such as e-weighing machine, moisture meter, oil content testing machine, manpower and handling arrangement etc. required for procurement under PSS guideline.
 - e) Maintain proper procurement records (physical and electronic)
 - f) Coordinate with designated warehouses for stock deposition and WHR generation.
 - g) Ensure that no unauthorized charges are collected from farmer.
 - h) Cooperate with inspection, audit and verification by Central Nodal Agency (SNA)/State Level Agency (SLA) or any Govt. Authorities.
 - i) Data entry of daily procurement on the portal/procurement system.

5. Eligibility Conditions

- 5.1. The applicant must be a legally registered PACS/FPO/FPC under relevant Act.
- 5.2. Applicant PACS/FPO/FPC, who possess prior purchasing experience under the PSS/PSF and against whom no adverse facts exist, shall be accorded preference in the selection process.
- 5.3. In case of FPO/FPC :
 - 5.3.1. Minimum two (02) years of existence as on date of publication of this EoI.
 - 5.3.2. Minimum 300 active farmer members in proposed area.
- 5.4. The applicant PACS/FPO/FPC must be financially sound and financially capable of bearing the costs of gunny bags, handling, transportation, etc for operation of procurement centre under PSS.
- 5.5. The applicant shall be responsible for making their own arrangements for gunny bags and transportation, as well as bearing the associated costs; payment for the same will be made after receipt of funds at the rate prescribed by the Central Nodal Agency.
- 5.6. Each PACS/FPO/FPC shall be permitted to operate only one (01) procurement centre.
- 5.7. Procurement operations shall be conducted only in those villages/talukas where the applicant's registered farmer members are present.
- 5.8. PACS/FPO/FPC shall not be allowed to act as State Level Agency (SLA) under PSS.
- 5.9. The applicant must not be blacklisted or debarred by any Government Department/ organisation/PSUs

6. Mandatory Documents/Certificate for applicants:

- 6.1. The application for empanelment with the detail of FPO/FPC/PACS and detail of proposed centre (Place, block, Tehsil & District) along with the self-attested documents in prescribed Annexure-1.
- 6.2. Registration Certificate
- 6.3. Detail of Directors.
- 6.4. Board Resolution/Authorization Letter.
- 6.5. The Contact Detail (Name, mobile, email, Aadhar no) of proposed Centre Incharge with copy of Aadhar.
- 6.6. The FPO/FPC must be submit Self certified list of minimum 300 farmer members of concerned area. In case of PACS, the applicant will submit their member list.
- 6.7. AOA/MOA/Bye-laws
- 6.8. PAN Card
- 6.9. GST Registration
- 6.10. CA Certified Balance Sheet & Audit Report of any 02 Preceding financial years from FY 2023-24 to 2025-26 with UDIN. *In case the applicant's registration is just completing two years and the Balance Sheet for the year 2025-26 has not been finalised, then the Turnover Certificate issued by CA for the year 2025-26 will have to be attached.*
- 6.11. Valid Election Result (only for PACS)
- 6.12. Affidavit/Declaration regarding non blacklisting and no adverse facts existencin Annexure-2
- 6.13. Detail with evidence against prior experience to successful execution of purchase under the PSS/PSF, if any.

7. Evaluation Process

- 7.1. Applications will be scrutinized by a constituted Committee.
- 7.2. HOFED may conduct physical verification of infrastructure required under PSS guideline and membership detail (if required)
- 7.3. The FPOs/FPCs/Primary Cooperative Societies, engaged with HOFED in the last season, will be considered for further retention on the basis of their performance.
- 7.4. Applicant PACS/FPO/FPC, that are financially sound enough to bear the expenses required for packaging materials, transportation & centre operations and also who possess prior purchasing experience under the PSS/PSF and against whom no adverse facts exist, shall be accorded preference in the selection process.
- 7.5. Proposals will be considered from districts where the FPO/FPC has its registered office or branch office and where there are 300 farmer members.

8. Execution of Agreement :

The PACS/FPO/FPC, whose offer has been accepted have to compulsorily complete the following proceeding, failing which the empanelment will automatically cancelled and it will not be mandatory for HOFED to give any information to the firm :-

- a) Execute an Agreement with HOFED on non judicial stamp paper of Rs. 100/- after approval of Purchase Centre from District Administration.
- b) Pay an amount of Rs 10,100/- to HOFED towards Nominal Membership Fee of Rs 100/- and Administrative Charges of Rs 10,000/year.
- c) Deposit an amount of Rs 5.00 Lacs (Rupees Five lacs) with HOFED as interest-free Security deposit/Performance Guarantee to safe guard the interest of farmer,

The Payment towards Nominal Membership Fee & Performance Guarantee/Security Deposit will be deposit through NEFT/RTGS/online in the designated bank i.e. Beneficiary :U.P. State Horticultural Co.op Marketing Federation, A/c No. 120000579112, IFSC: CNRB0002186, Canara Bank, Sapru Marg, Lucknow.

Note::The FPO/FPC/PACS shall be solely responsible for the duties and obligations of the personnel deployed at the procurement center. For safeguard in the interest of farmer, it is suggested that the FPO/FPC/PACS shall obtain a 'Fidelity Guarantee Insurance Policy' with a minimum coverage of ₹ 10.00 lakh from an Insurance Company.

9. General Conditions

- 9.1. HOFED reserves the right to accept or reject any or all applications without assigning any reason.
- 9.2. Empanelment does not provide guarantee for allocation of procurement centre/target.
- 9.3. Any false information or forged documents shall lead to rejection and may result in legal action.
- 9.4. HOFED may suspend or cancel empanelment in case of violation of guidelines/ instructions.
- 9.5. This Eol does not create any contractual relationship.

10. Submission of Proposal: Proposal alongwith necessary documents shall be submitted to the Managing Director, HOFED, 18-B, Ashok Marg, Lucknow.

11. Declaration

- 11.1. This Eol is published in compliance with GoUP Letter dated 25-06-2026 and applicable PSS Guidelines. All procurement operation shall be governed by Government instructions issued from time to time.
- 11.2. Failure to provide information that is essential to evaluate the applicant qualifications or substantiation of the information supplied, shall result in disqualification of the applicant. If any information found wrong, mislead or manipulated, the HOFED may reject Eol proposal or empanelment at any point of time which will be binding to organization.
